- **BID EXTENSION** If another bid is placed 10 minutes before the closing time of the online sale, the closing time of the relevant lot will be extended by 5 minutes until no more bids are made.
- **TEMPORARY** ADJUDICATION Some lots are sold under "Temporary Adjudication". This means that the seller (principal/leasing company) decides after the closing of the auction whether the lot(s) will be definitively allocated to the highest bidder.
- **COMBINATIONS** All lots will first be sold separately under suspension of higher bids in case of combination of lots. Afterwards, the combination of the lots will be sold. The opening bid of the combination is the total of the individual lots increased by 10%. If no bid is made for the combination, the separate allocations become final.
